## DESCRIPTION

1 Oxhill Road is comprised of an end of terrace two-storey brick built building surmounted by a pitch tiled roof and standing at the end of the small parade on Oxhill Road, which consists of roughly 8 similar retail units - all of which benefit from off-road side parking. The property is currently let to Bathing Mobility Advisory Service Ltd, whom are the assigners of the lease which is running a term of 6 years from 2023 incorporating a break in 2025 at the passing rent of £20,000 per annum.

## LOCATION

The unit is located in Solihull Lodge, just off Yardley Wood Road and 50 metres back from Maypole Lane. Immediate occupiers on the parade consist of a triple unit let to One Stop Convenience and Gatsbys Hair and Beauty. The parade benefits from significant thoroughfare for vehicles and is set within residential streets of Solihull Lodge with close proximity to Maypole Island and its adjacent superstores (4 min drive).

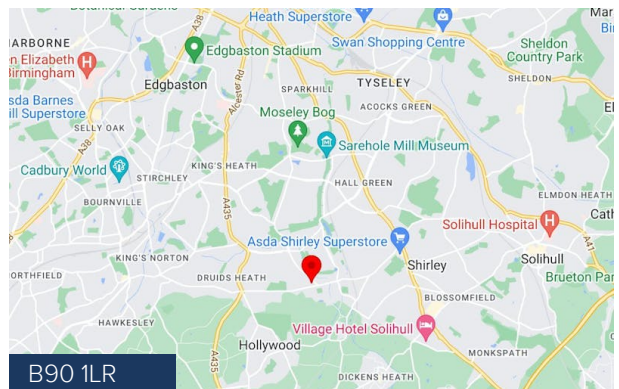
